- (b) Proof of Date of Birth (Matriculation Certificate showing date of birth or D.O.B. certificate issued by the Registrar of Births and Deaths).
- (c) Proof of Graduation Degree and detailed marks sheets of all years of graduation. If the degree has not been conferred, provisional degree be produced.
- (d) Category Certificate of the candidates belonging to different categories [except General (unreserved) Category] issued by the concerned authority appointed by the Government.
